

Vendor Rules & Regulations Agreement

for

The Juneteenth Community Celebration & Unity Walk at Powder Springs 2022

In this agreement, all references to **The Juneteenth Community Celebration & Unity Walk at Powder Springs 2022** presented by Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC. The following rules and regulations established by (hereby known also as **'The Juneteenth Celebration & Unity Walk'**) management team apply to all exhibitors/ vendors/performers. Approval for variances to these rules and regulations may be granted by program manager, in writing and at the sole discretion of the **Juneteenth Celebration & Unity Walk** management. Exhibitors must submit requests in writing or via email, at least 10 days prior to the event start date. Email requests to info@unityinhistory.org. Please keep in mind that an approved variance is the exception to the rule, not a right. Factors to be considered include but are not limited to the likelihood that a variance may adversely affect neighboring exhibits, aisle traffic or general character of **The Juneteenth Celebration & Unity Walk**.

Application Contract - Each exhibitor must execute a contract of which these Rules and Regulations are a part, for the right to use the space assigned. Signing the contract means you have accepted and agree to comply with all the Rules and Regulations. **The Juneteenth Celebration & Unity Walk** management has the right to deny any application. Monies for any application that is not approved will be returned to the contact listed on the application. Applications submitted without payment will not be processed and space will not be reserved. A service charge of \$40 will be imposed on any insufficient funds. **The Juneteenth Celebration & Unity Walk** management will pursue all legal and civil avenues allowable by law to collect the debt. Payment and Cancellation and Refund Policy - Full payment is due with a signed application to reserve space. No Refund will be issued in the event of natural disasters or other unavoidable circumstances, such a pandemic, rendering it impossible or impractical for **The Juneteenth Celebration & Unity Walk** to take place. In the event of a natural disaster or other unavoidable circumstances, such as a pandemic, the event organizers will make every effort to reschedule the event. If the event is rescheduled, Exhibitor will have a choice to participate and will receive a confirmed space within the rescheduled event. Exhibitor waives any claim for damages or compensation for cancellation.

Installation & Dismantling of Exhibits - All installation and setup of exhibits will be scheduled for 11:00 a.m. – 1:30 p.m. on Sunday, June 19, 2022. All exhibits must be fully operational by 2:00 p.m. for event start at 3:00pm. Any booths sampling or selling open food & beverages must have submitted an application to the Cobb & Douglas Public Health Department and must be prepared for a Cobb & Douglas County Public Health Department inspection as may be required on Sunday June 19, 2022. All vendor booths must have a tent and tents must be no more than 10x10. Tents must be secured with weights to prevent the wind from blowing them away and becoming a projectile. Take down will begin promptly at the close of the event at 8:01 p.m. on Sunday, June 19, 2022. Exhibitors may not exit the **The Juneteenth Celebration & Unity Walk**, nor dismantle their booth prior to the close of the event at 8:00 p.m. Garbage and other items from the exhibit must be disposed of properly and space must be Vendor Rules & Regulations clean of all material. Each exhibitor will be charged a refundable \$150 Clean Up Fee and \$200 for Food Vendors. Vendors will provide a check or money order for the Refundable Clean-up Fee. At the closing of the event, vendors will break down their booths and clean up their space. Any exhibitor that does not leave the space in the same condition as it was prior to installation, will forfeit their \$150/\$200 deposit. When the exhibitor space is inspected and confirmed clean, the refundable clean up fee check will be returned at that time or mailed to the exhibitor within 7 business days.

Selling & Sampling of Food and/or Beverages - All Caterers, Food vendors, Food Trucks must be licensed by the Cobb & Douglas County Public Health Department. Proof is required. There are no exceptions. Additionally, the exhibitor's booth must be prepared for a Cobb & Douglas County Health Department inspection as may be required on Sunday June 19, 2022.

Subletting of Space-Exhibitor may NOT assign, sublet, share or apportion to any other entity or individual all or any part of the exhibit space allocated and may not advertise or display goods or services other than those produced or sold by exhibitor in its regular course of business.

Responsibility - It is the responsibility of the exhibitor to follow all rules, regulations including state and federal laws. Exhibitors are responsible for any harm or injury caused to the public and other exhibitors.

Sale of Goods & Services - Exhibitor is solely responsible for obtaining any licenses, permits or approvals required under local or state law applicable to its activity and food vendors must be prepared for a Cobb & Douglas Public County Health Department inspection as may be required on Sunday June 19, 2022, as well as paying all taxes, license fees or other charges that shall become due to any government authority in connection therewith. All sales must be conducted within the confines of the booth and comply with all applicable federal, state, and local laws and regulations. Exhibitors will hold harmless by Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC.

The Juneteenth Community Celebration & Unity Walk at Powder Springs 2022 (Juneteenth Celebration & Unity Walk) event organizers, its officers, employees, volunteers, and members from any liability arising from the transactions taking place at **The Juneteenth Celebration & Unity Walk** event. The Juneteenth management reserves the right to restrict sales activities that it deems inappropriate or unprofessional.

City of Powder & Cobb County Parks & Recreation Facilities - In addition to the Rules and Regulations of **The Juneteenth Celebration & Unity Walk** organization, exhibitors must follow all City of Powder Springs and Cobb County Parks & Recreation Rules and Regulations. **The Juneteenth Celebration & Unity Walk** management reserves the right to remove and cancel the contract without refund of any Exhibitor that is not following the Rules and Regulations or due to the actions found offensive, not moral or harmful to either the public or other exhibitors. No articles may be posted, nailed or attached to any of the pillars, walls, doors, floors, grass both artificial and natural etc. Exhibitors will be held responsible for any damages done to any buildings, equipment or decorations and booth space.

Booth Accessibility (Including Product Demonstrations) - All exhibitors must comply with the Americans with Disabilities Act (ADA). Exhibitor warrants and represents that its exhibit at **The Juneteenth Celebration & Unity Walk** will be accessible to all individuals in accordance with the ADA. Each exhibitor has the responsibility to assure proper traffic flow through the event. Aisles must not be obstructed at any time. It is the exhibitor's responsibility to ensure safety measures are taken on all demonstrations.

Distribution of Material - Exhibitors may advertise their participation in **The Juneteenth Celebration & Unity Walk** event. Exhibitors who wish to include the sponsors in the advertisement must obtain written approval from the sponsors. Exhibitors may not distribute material outside their booth area without written permission from **The Juneteenth Celebration & Unity Walk** management.

Indemnification – Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC., management, its officers, employees, volunteers, and members are not responsible for damaged or stolen material/items. Exhibitors shall carry insurance to cover losses and agree to hold harmless, Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC. Management, its officers, employees, volunteers, members. Exhibitor agrees to indemnify and hold harmless Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC., **The Juneteenth Community & Unity Walk** management, its officers, employees, volunteers & members, and affiliates from any liability to any person or persons for or by reason of any condition, defect or otherwise, of any apparatus, equipment or fixtures furnished by the exhibitor in connection with this exhibit. Exhibitor further agrees to hold harmless Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC. **The Juneteenth Community & Unity Walk** management, its officers, employees, volunteers & members, Three Rounds, LLC., Event Management and affiliates from any liability to any person or persons for or by reason of any act or omission of said exhibitor, or any of his/her agents, servants, or employees. Indemnity includes, but is not limited to, claims of copyright, trademark or patent infringement, unfair competition, and product liability. The exhibitor, on signing the contract,

expressly releases the foregoing named association and individuals from any, and all claims for loss, damage, or injury. Exhibitor assumes entire responsibility.

Certificate of Insurance - Each exhibitor must at its sole expense, procure and maintain a Commercial General Liability insurance policy in the amount of at least one million dollars (\$1,000,000) OR sign a holds harmless agreement indemnifying Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC. and its affiliates. Exhibitor agrees to provide a current Certificate of Insurance (COI) to **The Juneteenth Community & Unity Walk** organizer Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC., management by May 19,2022 or submit the hold harmless agreement. Failure to provide proof of insurance or submit the hold harmless agreement will result in cancellation of booth space. The COI policy shall include the following required additional insured endorsement language: "Unity In HIStory Outreach Foundation, Inc., The City of Powder Springs, and Three Rounds, LLC.", its affiliates and each of their respective officers, employees, volunteers, and members.
